Get to Know Your Groundwater Sustainability Agency: North Fork Kings Groundwater Sustainability Agency

OVERVIEW

The Sustainable Groundwater Management Act (SGMA) is a new law that, once fully implemented, will fundamentally change the way we use and manage groundwater in California. The Act applies to areas that rely heavily on groundwater. The Act requires local agencies to form Groundwater Sustainability Agencies (GSAs) to manage and regulate groundwater. Once formed, these GSAs will have new powers, including the ability to limit or suspend groundwater pumping and charge fees for groundwater extraction and will be responsible for ensuring that groundwater conditions improve by 2040.



To do so, GSAs will need to develop and Implement Groundwater Sustainability Plans (GSPs). GSPs will need to document the groundwater conditions in the area; establish goals to prevent negative impacts; and identify projects and management actions that improve groundwater conditions.

SGMA intends to bring different water users together to decide how to use and manage groundwater. As a result, decisions made by the GSAs will affect residents in rural communities.
